



Memorandum of Understanding

between

the Institute of Criminological and Sociological Research, Belgrade

and

the Institute of Advanced Studies Kőszeg (iASK)

This agreement is made and entered into on the date of the final signature hereto, by the Institute of Criminological and Sociological Research, Belgrade and between the Institute of Advanced Studies Kőszeg in Kőszeg, Hungary.

Whereas the Institute of Criminological and Sociological Research, Belgrade and Institute of Advanced Studies Kőszeg (iASK) desire to engage in cooperative educational and research activities for the mutual benefit of both institutions, the parties have agreed to the following:

I. Activities

The cooperative activities to be covered by this agreement may include:

- Mutual participation in events (online and in-person) that are of interest to scholars and colleagues in each institute (i.e., lecture series, workshops, seminars and conferences);
- Mutual promotion of publications through online advertising and through dissemination throughout networks;
- Sharing of research resources when possible or needed;
- Provision of mutual opportunities to contribute to research, publications, and training programs at each other's institutes;
- Inclusion as partners in potential EU funded projects on topics of mutual interest and relevance.

II. Funding

Each institution will be responsible for seeking funds to support its involvement in the cooperative activities contemplated under this agreement, and all such activities will be dependent upon the budgetary appropriations of the parties.

III. Regulations and Coordination

All activities developed hereunder will be in accordance with all applicable rules and regulations of the home and host institutions, and all applicable federal, state and local laws, rules, and regulations.

The Institute of Criminological and Sociological Research, Belgrade appoints Ivana Stevanović, PhD, Director and the Institute of Advanced Studies Kőszeg appoints Prof. Dr. Ferenc Mislivetz, Director, to coordinate the development and implementation of this agreement.

IV. Agreement Terms

This agreement will be in effect for a period of three (3) years from the date of execution and may be renewed for an additional three (3) year period by the parties. Either party giving ninety days written notice to the other party may terminate the agreement provided that such termination will not affect the completion of any activity underway at the time or any previously advertised activity in which commitments to university students have been made.

V. Modifications

All modifications to this agreement must be in writing and signed by both parties.
